This is a follow up letter to our conversation on August 2, 2013. At that time, we spoke about your behavior that violated the sexual misconduct/cohabitation policy as outlined in the Student Handbook (p. 26/27). As a result of your actions, you will be placed on probation under contract effective immediately for 60 days -October 2nd, 2013. Per our conversation we invited you to participate in the following guidelines:

- 1. Tony will continue to meet with his counselor for the fall 2013 Semester.
- 2. Tony will secure a new living arrangement.
- 3. Tony will meet with Parker on a weekly basis for a minimum of a half an hour for the fall 2013 semester.
- 4. Suspension from athletic competition. Reinstatement to athletic competition will be at the discretion of the Coach and Athletic Director. The suspension will be a minimum of one meet.
- 5. Tony will complete 8 hours of service that will be signed off by Parker. Hours must be completed by December 13<sup>th</sup>, 2013.

We understand that your enrollment in the school is volunteer, and that your agreement to abide by this contract is entirely up to you. Failure to follow the guidelines of the Student Handbook which include subsequent violations that occur during or after this contract period, will result in further sanctions, which could include your dismissal from the University. This agreement will be formally reevaluated in approximately 60 days, at which point you will need to initiate a meeting with your Coach and the Dean of Students.

Tony, I hope you know my heart through this process is for you – for God to do His work in and through these circumstances in your life. Please accept the consequences within this contract in the same spirit through which they are being offered.

The Appeals Committee has received your appeal of the Disciplinary Contract dated August 2, 2013, and carefully reviewed the materials submitted with your appeal. This letter documents our conversation with you at William Jessup University on Friday, August 16, 2013.

While enrolled as a student in the summer 2013 term, you violated the Student Standards of Conduct by engaging in fighting or violent behavior, as defined by the Student Handbook: "Violent behavior towards another person will result in disciplinary action and may result in loss of housing privileges or dismissal" (Student Handbook 2012-13, p. 16, 20-21). The incident in question is the arrest on July 9, 2013, Booking/Registry Number 09741214. It has been determined that this incident also violates the terms of your athletic agreements.

As a result of your actions, you will be placed on probation under contract effective immediately for 60 days. The conditions for lifting the probation are as follows:

- 1. Meet with a professional counselor weekly for 60 days.
- 2. Meet with Coach Parker Daniells weekly for 60 days.

Agreement to abide by the terms of this contract as a basis for continued enrollment is your decision; if you so agree, please return a signed copy of this contract within 24 hours. This agreement will be formally reevaluated in approximately 60 days, at which point you will need to initiate a meeting with your Coach and the Dean of Students.

This is a letter to document our meeting on September £, 2013, and serves as official notification of your dismissal from William Jessup University based on your behavior in violation of University expectations in regards to fighting or violent behavior and the subsequent violation of your student conduct contract dated August 16, 2013. You will be formally withdrawn from your classes, and please contact the Student Finance offices to clear up any lingering account issues..

With respect to your dismissal, you are restricted from the property of the University and prohibited from attending any University-sponsored events. Your presence on University property, for any reason, without prior permission from this office will constitute violation of this restriction and you will be escorted off-campus by Campus Security.

You may petition for re-admission for the Fall semester of 2014 or following. This request should be sent to the Dean of Students no later than one month prior to the start of the desired semester of attendance. The following conditions for re-admission *consideration* include:

- Complete a short written statement addressing why you believe that the issues that
  resulted in your dismissal would not re-occur and how you would be an asset to the campus
  community in the event that you would be re-admitted to the University.
- Demonstrate learning and growth through involving others in your restoration process some options may include a mentor, professional counselor, and a local church body.
- Attend an interview for re-admission with the Dean of Students.

You have the right to appeal this decision in writing to Dr. Kay Llovio, Associate Provost for Educational Effectiveness as outlined in the Student Handbook.

Despite the difficulty of being dismissed, it is my prayer that you learn and grow as much from this experience as possible.
